

## **Operational Overview:**

As discussed in the Acute Care section below, the census numbers started the month very strong before moderating in the middle of the month. Other departments experienced mixed variances from their targets.

## EC Staffing and Admissions:


Our current census is 36 residents and holding due to a COVID outbreak. We have had several staff members out with it as well. However, we are beginning to see the end as residents are starting to come off of isolation. Once we have "the all clear", admissions will resume. Our goal was to reach 40 by the end of this year but, with the outbreak, we hope to achieve this census by mid to late January. Payor breakdown currently shows 11 are Private Pay and 24 Medicaid and 1 Medicare.

## **Nursing Administration:**

In the midst of a busy respiratory illness and holiday season we have several other big topics we are keeping our eyes on that might interest the Board.

- 1. Governor Inslee's proposed budget for the 2023-2025 biennium provides over \$50M in new funding to focus on fighting opioids and fentanyl: <a href="Press Release">Press Release</a>
- 2. Senate Bill 5236 requires expanded staffing committees be established by January 1st. Work at NVH is well underway to ensure we hit the ground running in 2024.

#### Acute Care:



The census was well above target for the first week of December with above average inpatients and swing beds. Volumes moderated towards the middle of the month.


## Quality/Infection Prevention:





## **Emergency Department:**



The Emergency Department has been consistently busy in December with several days of extremely high volumes.

Recently, patients presented to the ED requesting a sexual assault examination. At the time of presentation we had trained sexual assault nurses available in house and they were able to perform that exam. We hosted a SANE course here at NVH back in October and extended that training to four of our nurses. It is a difficult time for patients and it is nice that we now have the capacity to care for these patients. In these cases the patient did not have to travel and was able to seek the help they needed right here in our ED. Thankfully it is not a service needed in our area often.

## **Surgery:**

Dr. Dhillon has created a radio marketing campaign for Canadian Okanagan communities and we have started to receive our first responses from international patients. Navigating the travel and paying out of pocket is challenging for international patients but it provides an avenue to bypass what might otherwise be substantial delays in a service. Hopefully this trial period will demonstrate the effectiveness of reaching international patients.

## **Laboratory**





This month in the Laboratory we have decommissioned our Luminex Aries PCR analyzers "Ana" and "Lyza". After thousands of PCR COVID-19 tests we are no longer using these analyzers. The Luminex company has been purchased by a competitor and they have chosen to sunset the analyzers. Our PCR COVID testing has been replaced by the Spotfire analyzer and COVID continues to be included in the Biofire Respiratory Panel.

From all of us in the Lab we wish all our coworkers and community members a very merry holiday season and a healthy and happy new year!

## Radiology:



We continue to experience increased volumes driven in part by the ED increase and also by busier outpatient services.

Our ultrasound techs Kelsey and Shelley had applications training on December 5th and 6th. We are excited to have a new machine. Our old unit was leased back in 2013.

## **Allied Health:**

Allied Health Teams will be focusing on development of departmental goals and CQI for the coming year. We are fully staffed in rehab, and our numbers are finally back in the green! Wound clinic is fully staffed and Serene, our NAC, is working on her wound care tech certification. We are negotiating a plan to enhance RT coverage with our per diem RT, Kathy. Melissa Roberts continues to support nutrition



services virtually. Although Melissa is doing an awesome job, we recognize the importance of on site nutrition support and will be intensifying our search for a full-time Dietitian in the coming year.

Our rehab clerks are getting up to speed and doing an awesome job. This will allow our clerical supervisor to work with the other teams to continue improvements in workflow

and auditing with the goal being to improve time and efficiency in getting rehab billing out and any denials managed quickly and efficiently.

We will say goodbye to John Ehlers, OT, at the end of the year. John has been at NVH for 9 years. We thank him for his kind care of both our patients and our staff and wish him well in future endeavors.


## **Human Resources:**

## **Tonasket Family Medical Clinic:**

## Long Range Focus Committee:

The LRFC met on December 6th and continued its discussion on regional coordination of healthcare services. To organize the thoughts of the committee and to serve as a springboard for future communication, the group began work on a position paper to provide context and consideration for future work.

## Foundation (North Valley Community Health Association):

Foundation met on December 4th. Dixie Brown, treasurer, reported the Foundation's information with the State and IRS is up to date. The committee voted to reinvest funds, pledged to the hospital's construction project, in a six-month certificate of deposit. They discussed the GiveNCW annual fundraiser, which the committee promoted by sending out letters to past supporters of the Foundation; and also allocating funds in 2024 for mammograms. The next Foundation meeting has been rescheduled to January 8th, due to the New Year's holiday.

#### Building and Planning Committee:

Building and Planning met on December 14th and discussed the final weeks of the first phase of the construction project. Work is progressing on the ceiling grid and the crew will be wrapping up before Christmas.
